



**(GRANGE ROAD, ALLOA)
(TEMPORARY NO PARKING) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Grange Road, Alloa) (Temporary No Parking) Order 2025" and notwithstanding the date hereof, the Schedule 1 shall come into operation from 1700 hours on Thursday 30th October 2025 until 2000 hours on Saturday 1st November 2025.
2. The effect of this Order is that there will be no parking at any time during:

The period from 1700 hours on Thursday 30th October until 2000 hours on Saturday 1st November 2025, on the section of roads described in Schedule 1. The temporary no parking is required for Sparks in the Park event.
