



**(UPPER HILLFOOT ROAD, DOLLAR)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Upper Hillfoot Road, Dollar) Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule 1 shall come into operation from 1000 hours until 1130 hours on Tuesday 11th November 2025.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 1000 hours until 1130 hours on Tuesday 11th November 2025, on the section of roads described in Schedule 1. The temporary prohibition of driving, parking and loading is required to facilitate works by Scottish Water.

Diversion Via Upper Hillfoot Road, A91, Manse Road, The Ness, Tarmangie Drive and vice versa. The order runs from 1000 hours until 1130 hours on Tuesday 11th November 2025. 
