



**(VARIOUS STREETS, ALLOA)

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary No Parking) Order 2025" and notwithstanding the date hereof, the Schedule 1 shall come into operation from 0800 hours on Monday 3<sup>rd</sup> November 2025 until 1700 hours on Friday 14<sup>th</sup> November 2025.
2. The effect of this Order is that there will be no parking at any time during:

The period from 0800 hours on Monday 3<sup>rd</sup> November 2025 until 1700 hours on Friday 14<sup>th</sup> November 2025, on the section of roads described in Schedule 1. The temporary no parking is required for excavate, backfill and reinstate for 4way link box replacement.


