



**(VARIOUS STREETS, TILlicOUNTRY)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2026**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Tillicoultry) Temporary Prohibition of Driving, Parking and Loading) Order 2026" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours until 1800 hours on Monday 9th February 2026.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0930 hours until 1800 hours on Monday 9th February 2026, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for firestone ironwork repairs. Local diversion in place.

The order runs 0930 hours until 1800 hours on Monday 9th February 2026. The temporary prohibition of driving, parking and loading is required for firedstone ironwork repairs.
