The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (C88 From A977 Forestmill to Meeks Park Road) Temporary Prohibition of Driving, Parking and Loading) Order 2026" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Wednesday 18<sup>th</sup> February 2026 until 1800 hours on Tuesday 3<sup>rd</sup> March 2026.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0800 hours on Wednesday 18th February 2026 until 1800 hours on Tuesday 3rd March 2026, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for bridge repairs.

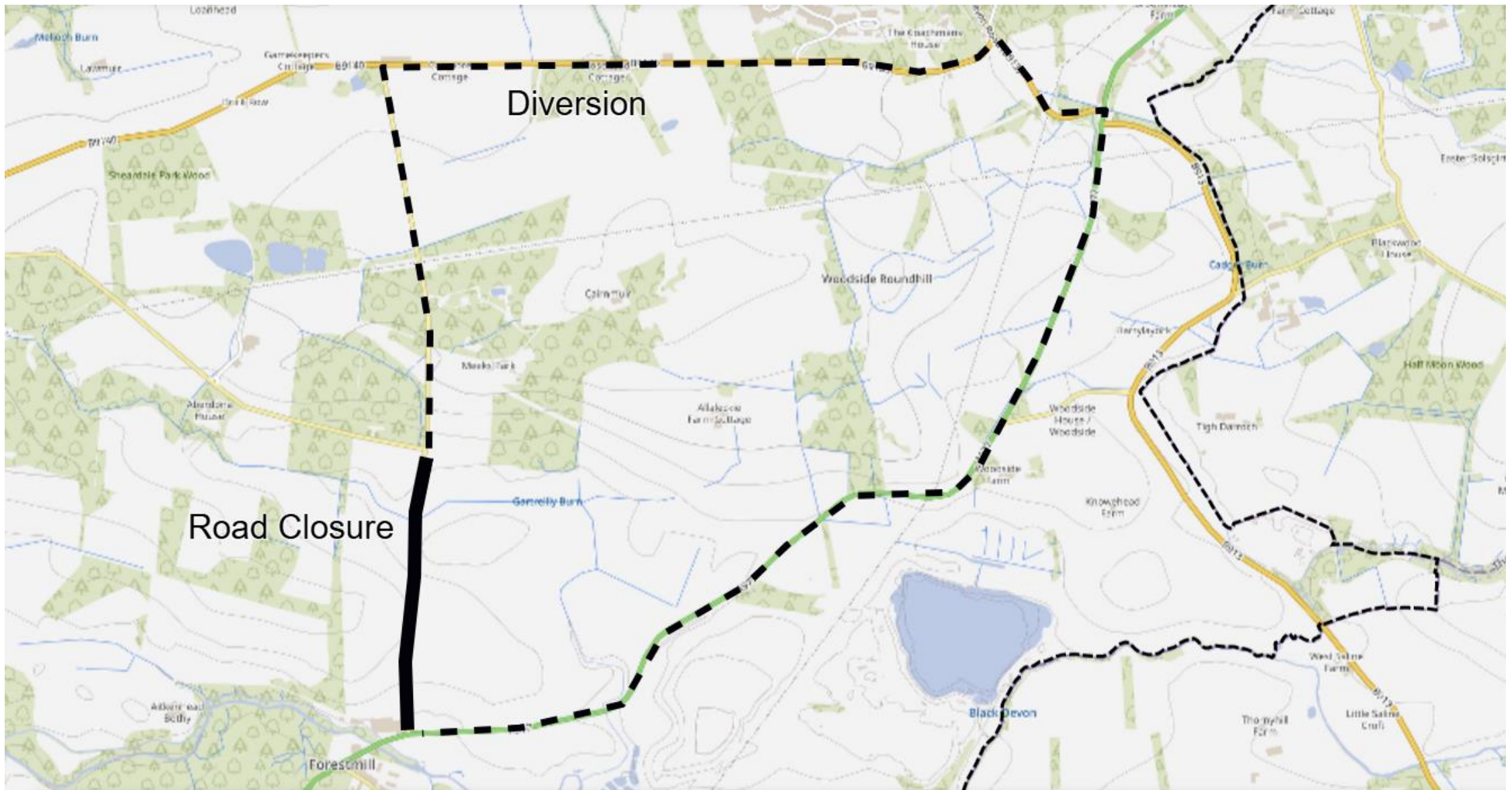
