1. This Order may be cited as "The Clackmannanshire Council (A908 Alexandra Street, Tillicoultry) (Temporary No Parking) Order 2026" and notwithstanding the date hereof, the Schedule 1 shall come into operation from 0930 hours until 1800 hours on Monday 23<sup>rd</sup> February 2026.
2. The effect of this Order is that there will be no parking at any time during:

The period from 0930 hours until 1800 hours on Monday 23<sup>rd</sup> February 2026, on the section of roads described in Schedule 1. The temporary no parking is required for ironwork repairs.
