



**(BRUCEFIELD ROAD, FORESTMILL)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2026**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Brucefield Road, Forestmill) Temporary Prohibition of Driving, Parking and Loading) Order 2026" and notwithstanding the date hereof, the Schedule shall come into operation at 0730 hours on Monday 2nd March 2026 until 1700 hours on Monday 6th March 2026.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0730 hours on Monday 2nd March 2026 until 1700 hours on Monday 6th March 2026, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for carriageway surfacing.

The Council has made "The Clackmannanshire Council (Brucefield Road, Forestmill) (Temporary Prohibition of Driving, Parking and Loading) Order 2026, under the Road Traffic Regulation Act 1984 (as amended) on 17th February 2026: where there will be a temporary prohibition of driving, parking and loading at **Brucefield Road, Forestmill** (From a point 374 metres from the Clackmannanshire boundary, northwards for a distance of 400 metres or thereby). Diversion Via Brucefield Road, C89, A977, A907, Brucefield Road and vice versa. The order runs from 0730 hours on Monday 2nd March 2026 until 1700 hours on Monday 6th March 2026. 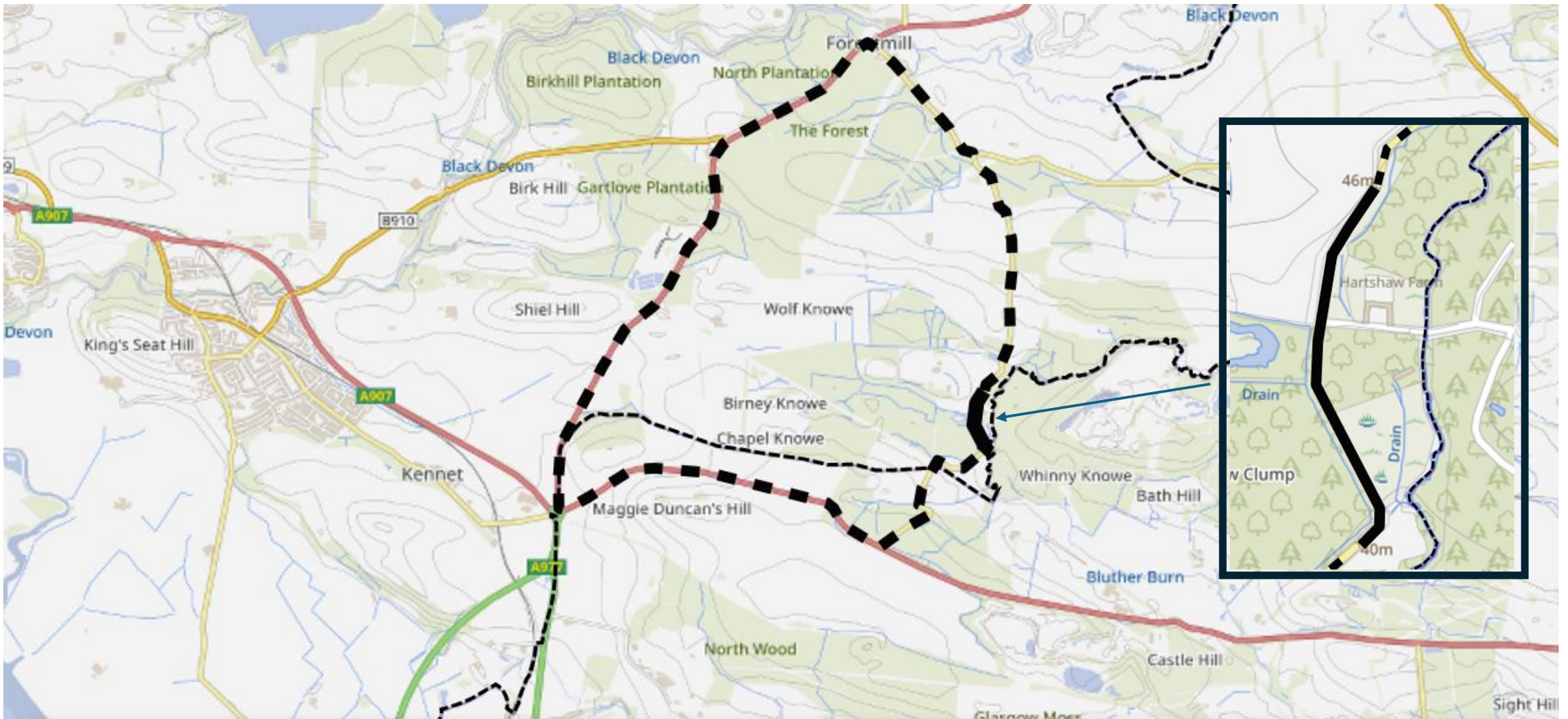
