



**(VARIOUS STREETS, ALLOA)
(TEMPORARY ROLLING ROAD CLOSURE) ORDER 2026**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Rolling Road Closure) Order 2026" and notwithstanding the date hereof, Schedule shall come into operation at 0900 hours on Sunday 22nd March 2026 and will remain in operation until 1000 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0900 hours until 1000 hours on Sunday 22nd March 2026, on the section of roads described in Schedule. The temporary closure is required to facilitate the safe passage in the Alloa Half Marathon.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Rolling Road Closure) Order 2026, under the Road Traffic Regulation Act 1984 (as amended) on 3rd February 2026: to close to vehicles the section of road at **B9096 Tullibody Road, Alloa** (from its junction with Ormiston Drive eastwards until its junction with Mar Place, a distance of 1.785 kilometres or thereby), **Ashley Terrace, Alloa** (from its junction with Sunnyside Road westwards until its junction with Tullibody Road, a distance of 1.020 kilometres or thereby), **Mar Place, Alloa** (from its junction with Tullibody Road eastwards until its junction with King Street, a distance of 167 metres or thereby), **Parkway, Alloa** (from its junction with Mar Place northwards until its junction with Sunnyside Court, A distance of 250 metres or thereby, **Sunnyside Road, Alloa** (from its junction with Sunnyside Court northwards until its junction with Ashley Terrace, a distance of 377 metres or thereby, **A91 King Street, Alloa** (from its junction with Mar Place eastwards until its junction with Shillinghill Roundabout, a distance of 450 metres or thereby), **A908 Whins Road, Alloa** (from its junction with Shillinghill Roundabout northwards until its junction with Whins Road Roundabout, northwards for a distance of 670 metres or thereby). 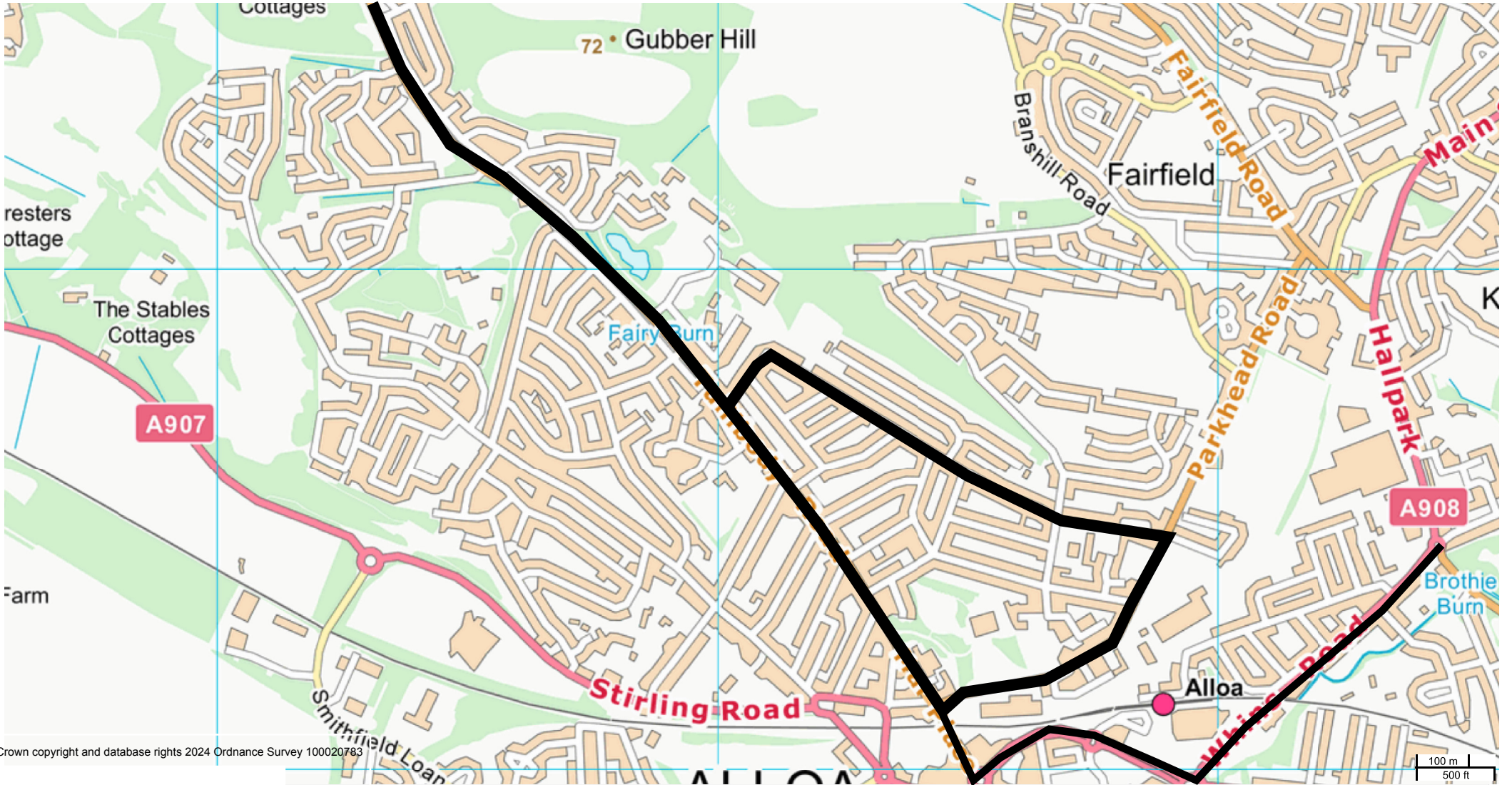
