



**(ALLOA HALF MARATHON)
(TEMPORARY PROHIBITION OF TURNING) ORDER 2026**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Alloa Half Marathon) (Temporary Prohibition of Turning) Order 2026" and notwithstanding the date hereof, the Schedule shall come into operation at 0900 hours on Sunday 22nd March 2026 and will remain in operation until 1200 hours on that day.
2. The effect of this Order shall be to prohibit vehicles:-

From turning in the sections described in the schedule hereto to facilitate the safe passage of participants in the Alloa Half Marathon during the period from 0900 hours until 1200 hours on Sunday 22nd March 2026.

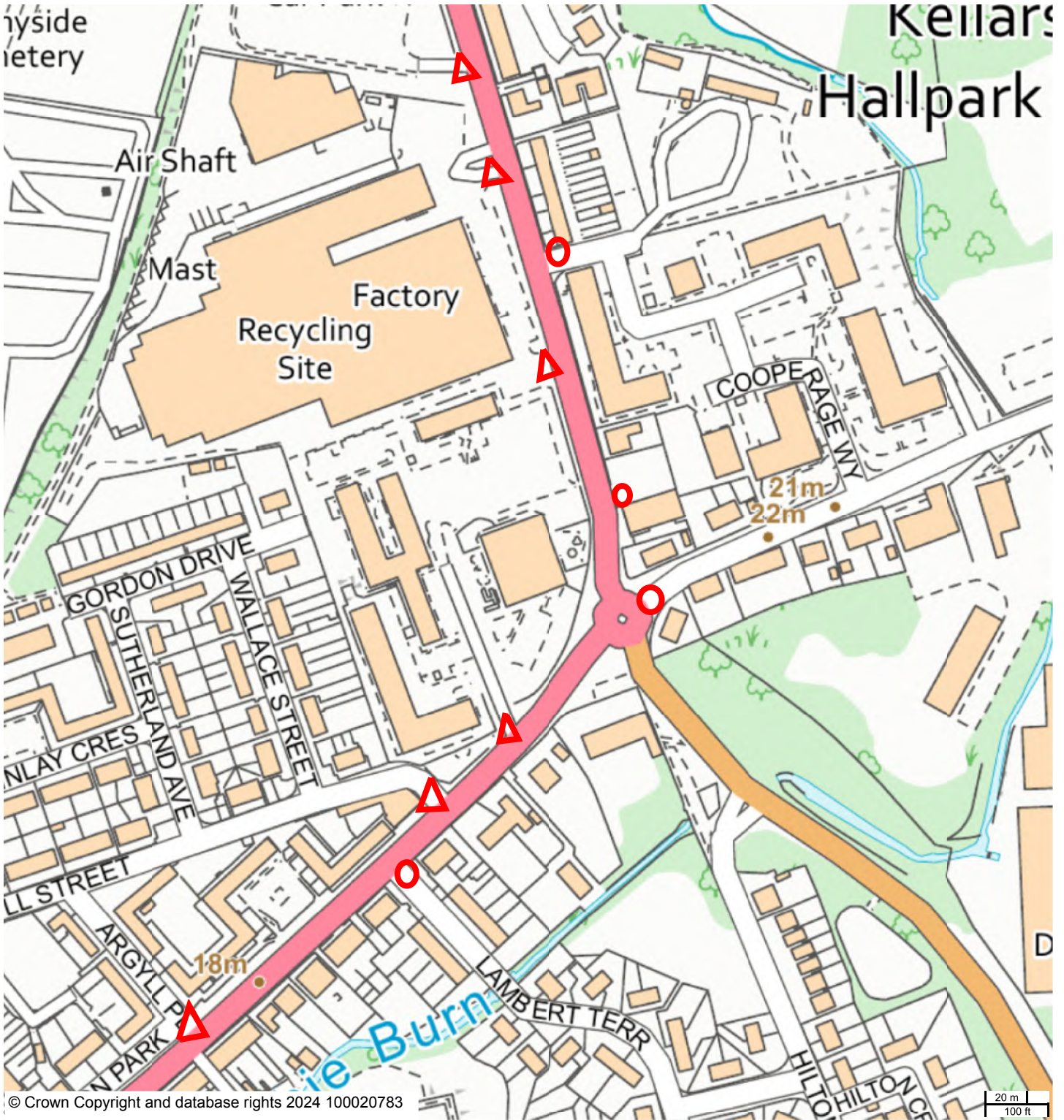

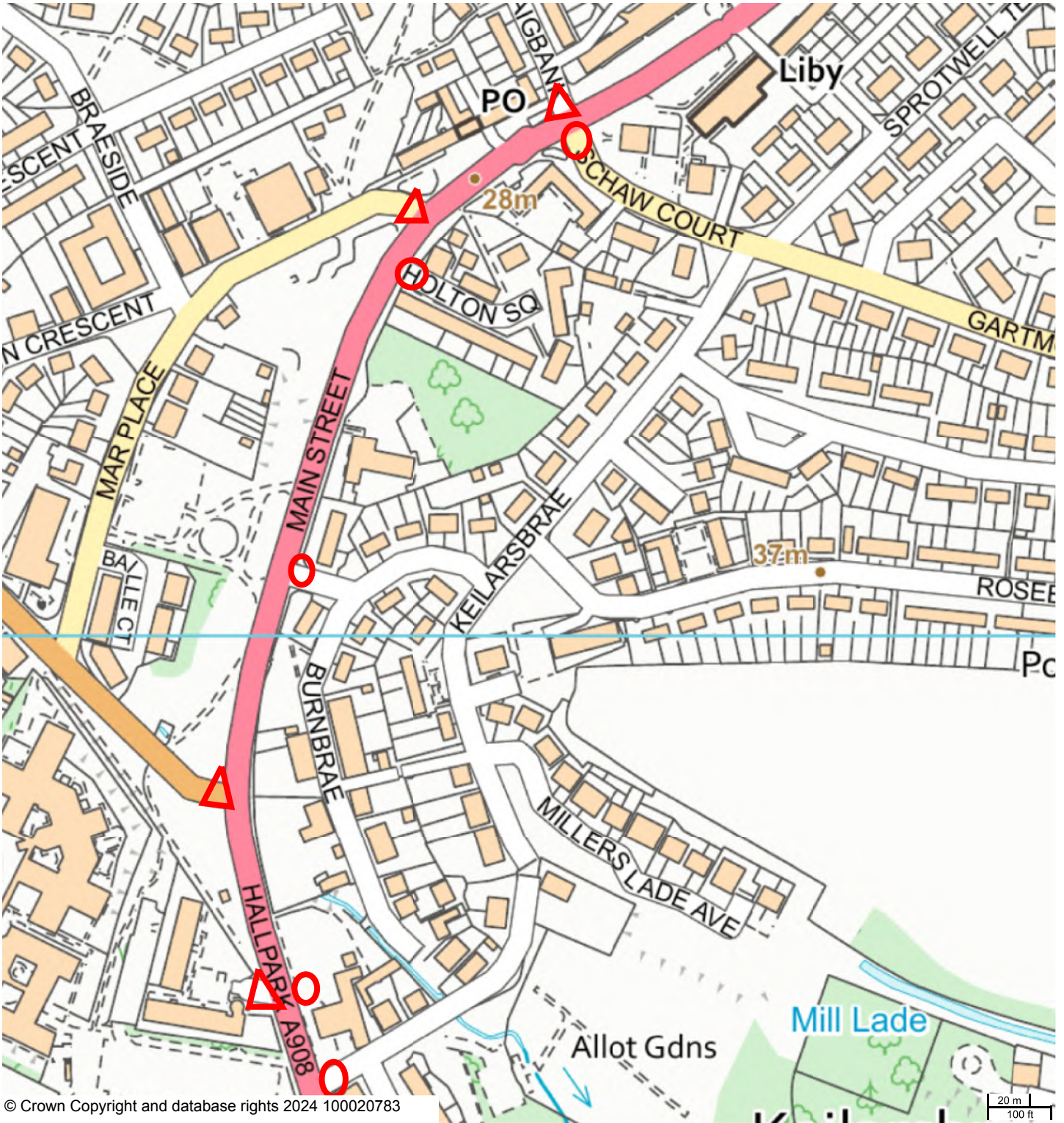

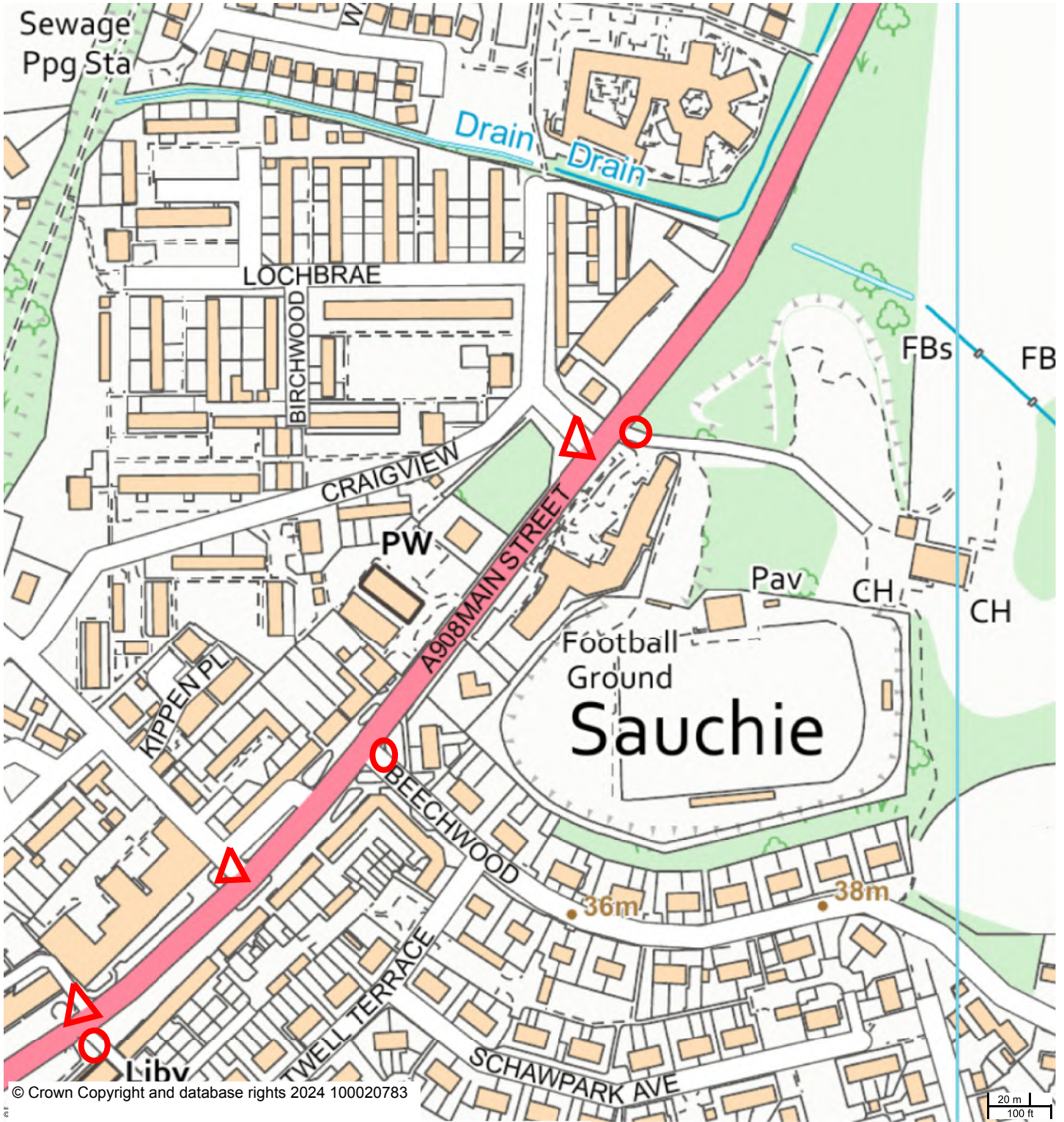

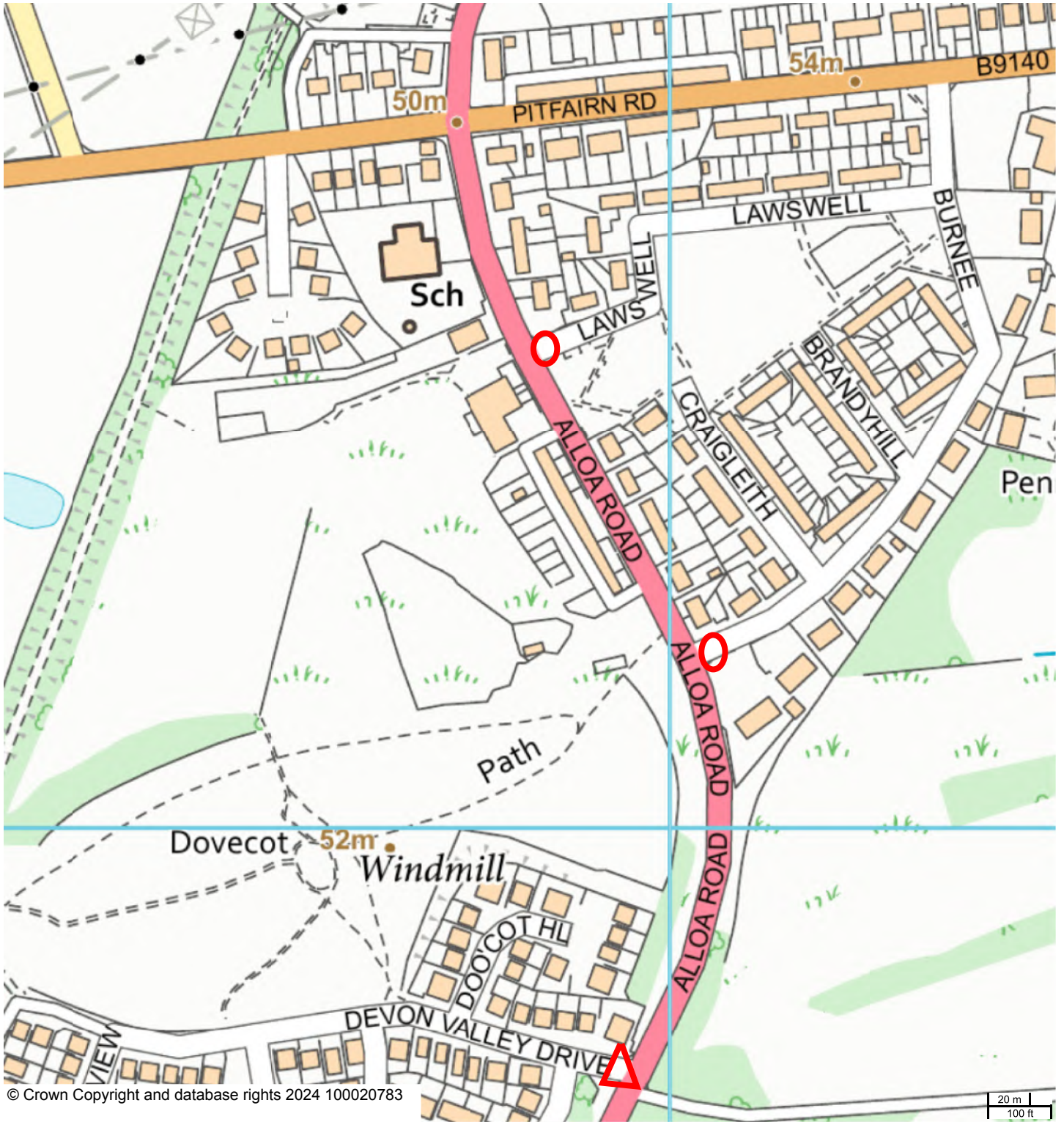
