



**(SMITHFIELD LOAN, ALLOA)  
(TEMPORARY SPEED RESTRICTION) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Smithfield Loan, Alloa) (Temporary Speed Restriction) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 29<sup>th</sup> September 2025 for a period of 18 months.
2. The effect of this Order shall be to reduce the speed to 20mph zone:

The period from 0800 hours on Monday 29<sup>th</sup> September 2025 for a period of 18 months, on the section of roads described in Schedule. The temporary speed restriction is required for road safety during the construction phase of the Wellness Hub.

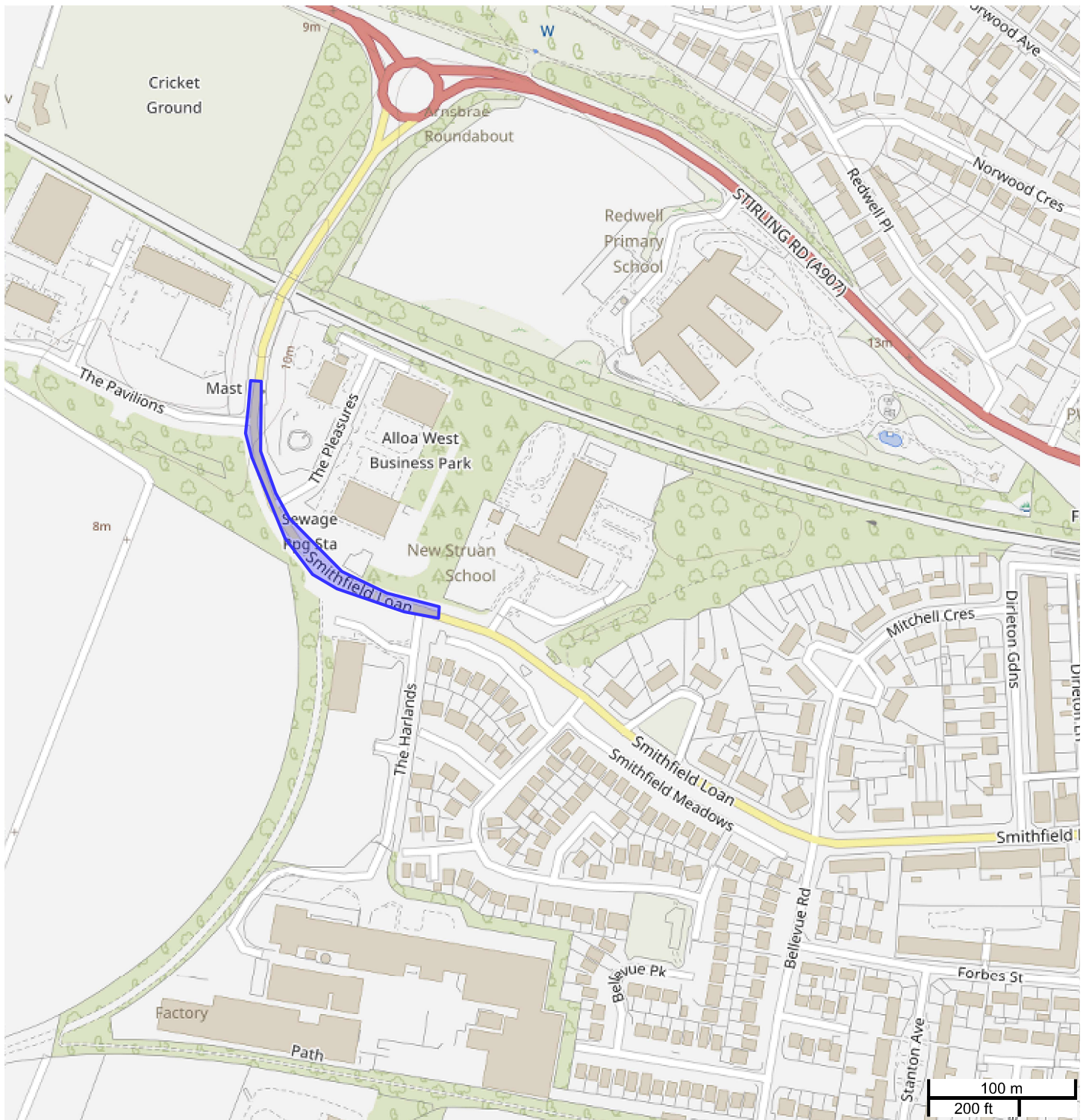
