

**THE CLACKMANNANSHIRE COUNCIL
(VARIOUS STREETS, CLACKMANNASHIRE)
(20 MPH SPEED LIMIT) EXPERIMENTAL ORDER 2026**

Clackmannanshire Council, in exercise of the powers conferred upon it by Sections 9, 10 (2), 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

- (1) This Order may be cited as "The Clackmannanshire Council (Various Streets, Clackmannanshire) (20 mph Speed Limit) Experimental Order 2026" and shall come into operation on 21 May 2026 and will apply for a period of up to 18 months.
- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (3) A speed limit of 20 miles per hour is hereby imposed on the lengths of roads specified in the Schedule to this Order and no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the said lengths of roads.
- (4) The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.
- (5) The Director (Place) of Clackmannanshire Council may, if it appears to him essential in the interests of the expeditious, convenient, or safe movement of traffic, or for preserving or improving the amenities of the area, and after such consultation and notice as are required by law, modify or suspend the operation of this Order or any provisions of it in accordance with Section 10(2) of said Act.

The Council proposes to make the above Experimental Order under Sections 9, 10(2), 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. This will designate the sections of roads in Clackmannanshire: **C59 Alloa Road, Clackmannan** (From its junction with Cattlemarket eastwards until the Clackmannan boundary (east of Mannan Drive), a distance of 785 metres or thereby). **Branshill Road, Sauchie** (From its junction with B908 Parkhead Road, north westwards for a distance of 685 metres or thereby) as a 20 miles per hour speed limit to trial a reduction in the speed limit in the interests of road safety. The traffic order will be in place for up to 18 months and will be used to monitor the effectiveness of the experimental speed limit on these roads. 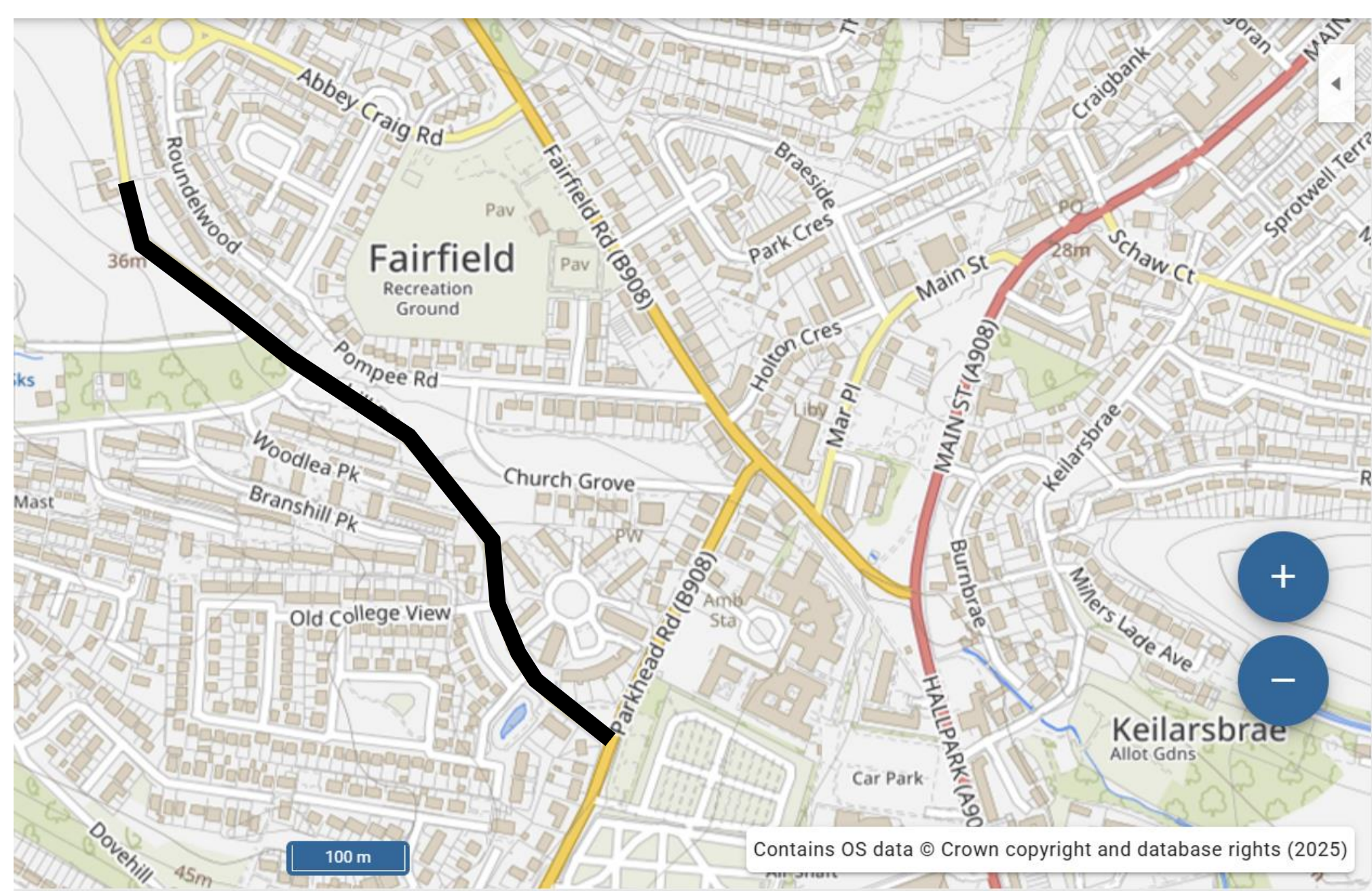
