

**(GLASSHOUSE LOAN, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2026**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Glasshouse Loan, Alloa) Temporary (temporary prohibition of driving, parking and loading) Order 2026 and notwithstanding the date hereof, the Schedule shall come into operation from 0700 hours until 1500 hours each day between Monday 20th April 2026 until Friday 1st May 2026.

2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0700 hours until 1500 hours each day between Monday 20th April 2026 until Friday 1st May 2026, on the section of roads described in the Schedule. The temporary prohibition of driving, parking and loading is required for carriageway resurfacing works.
