- 1 This Order may be cited as "The Clackmannanshire Council (Ashley Terrace, Alloa) Temporary (prohibition of driving, parking and loading) Order 2026 and notwithstanding the date hereof, the Schedule shall come into operation from 0700 hours on Monday 13th July 2026 until to 1600 hours on Friday 24th July 2026, on the section of roads described in the Schedule.
- 2 The effect of this Order is that there will be temporary prohibition of driving, parking and loading at any time during:
