The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1 This Order may be cited as "The Clackmannanshire Council (Various Streets, Tullibody) Temporary (prohibition of parking) Order 2026 and notwithstanding the date hereof, the Schedule shall come into operation from 0930 hours until 1800 hours on 22nd July 2026, on the section of roads described in the Schedule.

2 The effect of this Order is that there will be temporary no waiting at any time during:

The period from 0930 until 1800 hours on 22nd July 2026, on the section of roads described in the Schedule. The order is required for Scottish Water works.
