The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1 This Order may be cited as "The Clackmannanshire Council (Main Street, Clackmannan) Temporary (prohibition of driving, parking and loading) Order 2026 and notwithstanding the date hereof, the Schedule shall come into operation from 0700 hours on Monday 27th July 2026 until to 1600 hours on Friday 7th August 2026, on the section of roads described in the Schedule.
- 2 The effect of this Order is that there will be temporary prohibition of driving, parking and loading at any time during:

The period from 0700 hours on Monday 27th July 2026 until to 1600 hours on Friday 7th August 2026, on the section of roads described in the Schedule. The order is required for carriageway resurfacing works.

The Council has made "The Clackmannanshire Council (Main Street, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2026, under the Road Traffic Regulation Act 1984 (as amended) on Tuesday 23rd June 2026: where there will be a temporary prohibition of driving, parking and loading at **Main Street, Clackmannan**: From its junction with Port Street eastwards until its junction with Castle Street, a distance of 200 metres or thereby. **Diversions**: Via Port Street, Lochies Road, Castle Street, South Pilmuir Road and vice versa. The order runs from 0700 hours on Monday 27th July 2026 until 1600 hours on Friday 7th August 2026, on the section of roads described in the Schedule.
