1 This Order may be cited as "The Clackmannanshire Council (Moss Road, Tillicoultry) Temporary (prohibition of parking) Order 2026 and notwithstanding the date hereof, the Schedule shall come into operation from 0800 hours on Monday 3rd August 2026 until to 1700 hours on Tuesday 11th August 2026, on the section of roads described in the Schedule.

2 The effect of this Order is that there will be temporary parking suspension at any time during:
