The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Vicar's Bridge Road, Dollar) Temporary (prohibition of driving, parking and loading) Order 2026 and notwithstanding the date hereof, the Schedule shall come into operation from 00:01 hours on Monday 24th August 2026 until 23:59 hours on Friday 28th August 2026, on the section of roads described in the Schedule.
2. The effect of this Order is that there will be temporary prohibition of driving, parking and loading at any time during:

The period from 00:01 hours on Monday 24th August 2026 until 23:59 hours on Friday 28th August 2026, on the section of roads described in the Schedule. The order is required to carry out drainage works.
