- 1 This Order may be cited as "The Clackmannanshire Council (Greenside Street Car Park, Alloa) Temporary (prohibition of driving, parking and loading) Order 2026 and notwithstanding the date hereof, the Schedule shall come into operation from 05:00 hours on Saturday 15th August 2026 until 15:00 hours on Friday 4th September 2026, on the section of roads described in the Schedule.
- 2 The effect of this Order is that there will be temporary prohibition of driving, parking and loading at any time during:
