



## Code of Conduct for customers taking part in tubing sessions at Firpark Ski Centre

Tubing sessions are available on Saturday and Sunday 5.00-6.00pm or 6.00-7.00pm. Due to their popularity, advance booking is essential.

Tubing is a high risk activity and therefore safety rules must be adhered to.

### General information

1. 15 tubes are available for a maximum of 15 people at an hourly rate of £111.00 or up to 30 people for £176.50.
2. If there are under 16's in the group, two responsible adults must be available to help supervise the let under the direction of the tubing supervisors.
3. The minimum height for tubing is 110cm (measurement available within the Ski Centre)
4. Your let is 60 minutes on the ski slope. There is no indoor alternative apart from access to toilets and first aid.
5. Participants will receive and must attend the safety talk prior to the start of the tubing.

### Important safety rules

6. It is mandatory that all participants wear a helmet provided by the ski centre.
7. All participants **must** wear full finger gloves, long sleeved clothing, long trousers and strong footwear (trainers are ideal). Waterproof clothing is not essential but can be worn.
8. Only **one person in a tube at any time.**
9. No participant will go higher than the blue line on the ski slope, or as specified by the tubing supervisor on duty.
10. Only authorised spectators can be inside the ski area but must stand to the side of the slope to avoid collision with tubes.
11. Adults will be required to escort young children to the toilet where appropriate.
12. Once a tube has reached the bottom of the ski slope participants should always look up the slope to check that there are no tubes sliding down before getting out of the tube.

**Do not** get out of the tube if someone is coming down the ski slope. Once safe to do so, exit the tube and walk towards the pump house (shed at bottom of the slope).

13. Tubing supervisors will release tubes according to safety.
14. All accidents/dangerous occurrences **must be recorded** on Clackmannanshire Council's accident report form available at the venue.
15. Parents/carers going up the ski slope must follow the health and safety guidelines of the tubing supervisors at all times or they shall be asked to return to the bottom of the slope.
16. All medical conditions and additional needs must be reported to the tubing supervisor at the start of the let.

## Venue rules

17. Firpark Ski Centre is not liable for the property of customers.
18. Any damage to equipment is the responsibility of the user.
19. As a Council venue no alcohol or smoking/e-cigarettes is permitted in the ski centre or within the boundary of the ski slope.

**Failure to follow tubing supervisor's guidelines may result in your tubing let being stopped or cancelled.**

**Please note there is a 'no refund policy'.**
